PAYMENT

Payment of the renting to Lodges Méditerranée by :

The balance, the optional services provided, the stay's tax will be paid at the arrival before entering in the house.

As soon as we receive the form and the deposits or the whole payment of the stay, you will be sent a « booking confirmation » that will be required at your arrival.

CONDITIONS OF BOOKING

• BOOKING

The deposits equivalent to 25 % of the whole stay is necessary as soon as the booking. **The rest has to be paid 30 days before the stay's date. For the booking effectuated less than 30 days before the stay's date, the payment has to be done at the same time than the booking.** The tourist tax and the extra charges will be paid at the arrival. **Your booking is definitive as soon as LODGES MEDITERRANEE confirms by a letter.**

• PRICES

The whole price **includes all the taxes** plus the renting of the house, **except** the tourist tax that you will pay at your arrival (see fare).

• CANCELLATION

If you cancel your booking, you must write a letter with a report at LODGES MEDITERRANEE. The refund of your payment will be done as the following procedure :

- ✓ more than 30 days before the stay's date : SARL LODGES MEDITERRANEE will keep the deposits
- ✓ less than 30 days before the stay's date: SARL LODGES MEDITERRANEE will keep 100% of the whole payment of the stay

In case of a cancellation instead of SARL LODGES MEDITERRANEE, except for an important reason, the whole price will be refunded.

No refund will be allowed in case of late arrival or anticipated departure.

• STAYS' TIME AND DATE

The stays last minimum one week from June 26 at August 28, 2010

- ✓ **Arrival : Saturday at 5 pm**
- ✓ **Departure : Saturday before 10 am**

Apart from this period, the arrivals are possible every day making appointment to the office hours except Sundays when the reception is closed, from April 3 at June 26 and from August 28 at October 2, 2010.

At your arrival, you must:

- ✓ **present your booking confirmation at the office open on Saturday from 4 pm only in July and August** (different hours out of these seasons - you can contact us for more information)
- ✓ **pay the tourist tax and/or the extra charges**
- ✓ **present your pet's vaccination book (vaccination against rabies necessary)**

The maximum number of persons in an accommodation is the one allowed in the fare, whatever their age. The Direction of SARL LODGES MEDITERRANEE can refuse the access of the rented accommodation to the groups or family of an upper number of persons.

Reservations may be changed at no cost depending on availability. Management reserves the right to accept or refuse a reservation and to change the assignment of accommodation.

• EQUIPMENT

Each Lodge or cottage includes all the cooking material as well as the bedroom's equipment (except the bed sheets and the bathroom linen).

At your arrival, we will give you a stock list of the whole house's equipment. The tenant has to check it and to point any anomaly out to us, the arrival's day or the day after. We won't accept any complaint after this date.

• DEPOSIT

A deposit of 350 € (cheque, cash or bank card) has to be paid at the arrival and a deposit of 100 € if you want another badge for the parking.

It will be given back at the departure after having checked noticed damage and/or missing material. If any damage is noticed, LODGES MEDITERRANEE will keep the deposit.

The tenant is responsible for cleaning the lodge or the cottage.

At the end of the stay, the accommodation must be cleaned. If this shouldn't be the case, a sum of 50 € will be held on the deposit.

- **INSURANCE**

It is the tenant's responsibility to have personal civil liability insurance for each person residing with him or her in the rental, Lodges Méditerranée declining all liability for theft, fire, storms and incidents under the tenant's responsibility.

- **ANIMALS**

Domestic animals are allowed (cats and dogs except for the 1st category). They must be kept on a leash and vaccinated against rabies (2nd category dogs must also be muzzled). The animal's vaccination book must be presented upon arrival. Dogs are not allowed by the pools, in the restaurant, on the restaurant terrace or on the beach. It is the tenant's responsibility to be appropriately insured, Lodges Méditerranée declining all liability for theft, fire, storms and incidents under the tenant's responsibility.

- **TOURIST TAX**

A tourist tax will be paid at the arrival : about 0.44 € / day / person of more than 13 years old (fare 2006).
